A Missed Opportunity.By Nandt1A wide-ranging discussion of corruption around the world, written by an author described as

one of the founders of the leading anti-corruption organization Transparency International, sounds like an appealing read. Sadly the opportunity has been largely squandered. Neither Mr. Cockcroft nor his publisher seems to believe in doing one's research and -- especially -- checking one's facts. As a result, the book is littered on a large scale with factual errors both mundane (dates, proper names, etc.) and more consequential, including serious misreadings of the political context for corruption in a number of the countries discussed here (e.g., the depiction of Mario Vargas Llosa of Peru as a strong presidential candidate from the Left, when in fact he ran on a neo-liberal platform for a center-right party, or a scrambled account of the role of Mexico in the international cocaine trade). This is a lazily-written book and it shows. A pity!

Corruption has played a pivotal role in determining the current state of the world - from mass poverty in developing countries, to the destruction of natural resources and to the erosion of trust in political parties. Laurence Cockcroft here argues that corruption has to be seen as the result of the interplay between elite 'embedded networks', greed and organised crime. He shows how the growth of corruption has been facilitated by globalisation, the integration of new and expanding markets into the world economy, and by the rapid expansion of 'offshorer' financial facilities. These facilities provide a home to largely unregulated pools of finance derived from personal fortunes, organised crime and pricing malpractice in international trade. By identifying the main drivers of corruption worldwide and analyzing the current action to control them, this book suggests ways in which the problems caused by corruption can be addressed and ultimately prevented.
